COMPANY MANAGEMENT FEES REGULATIONS

Note: These Regulations are enabled under section 25 of the Company Management Act, R.S.A. c. C75.

Interpretation

1. In these Regulations—

“Act” means the Company Management Act;

“\$” means the currency of the United States of America.

Fees

2. The fee for a service set out in Column 1 below is the amount set out opposite in Column 2—

(1)	For filing application for licence under section 5 of the Act (Non-refundable)	500
(2)	For issue of a licence under section 6 of the Act—	
	(i) on or after July 1 in any year	1,000
	(ii) on or before June 30 in any year	2,000
(3)	For annual licence under section 8 of the Act.....	2,000
